This annual event honors the loggers of this area where their skills are shared and competition is at its peak. Food & Vendors are located on 7<sup>th</sup> Street in downtown Hoquiam. Set-up begins at 7:30 AM, festivities begin at 10 AM, and the vendor fair wraps-up at 4 PM. The parade at noon brings folks in for shopping and tasting. Logger's PlayDay climaxes at historic Olympic Stadium's nighttime logging show, which draws competitors from around the United States. Log rolling, choker-setting, tree-topping, ax-throwing and other combinations of blades, wood and skill are tested.
